PRIVACY POLICY

Protecting the security and privacy of your personal data is important to EMRAX. Therefore, the EMRAX company referred to under "EMRAX" operates its website in compliance with applicable laws on data privacy protection and data security.

In the following, we provide information on the kinds of data we collect on EMRAX website, the purposes for which we use such data, and the parties with which we share such data, where applicable.

Collected data and purpose of processing

We use cookies on our website. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance the experience on our site. Accesses to our website are logged for the purpose of security analysis reports and to defend against cyberattacks. Log data is promptly deleted on a regular basis.

In addition, we collect personal data (e.g., names, addresses, telephone numbers, or e-mail addresses) in connection with the operation of our websites only when you have voluntarily provided such data to us (e.g., through registration, contact inquiries, surveys, etc.) and when we are entitled to process or use such data by virtue of permission granted by you or on the basis of a statutory provision.

As a general rule, we use such data only for the purpose for which you divulged the data to us, such as to answer your inquiries, process your orders, or grant you access to certain information or offerings.

Sharing of data

Insofar as you have provided your consent or when we are otherwise legally entitled to do so, we will share your personal data with subsidiaries of EMRAX, where applicable, for the purposes indicated above. In connection with the operation of its website and the services provided by way of the website, EMRAX works with service providers such as hosting or IT maintenance service providers, for example. We do not sell or otherwise market your personal data to third parties.
